Requirements for McDonough Scholars

Any student employee of a New Hampshire golf course or club is eligible to apply for a scholarship. Candidates should demonstrate promise of academic success, as well as require financial assistance. Once awarded, a McDonough scholarship may be renewed each year for a total of four years. Annual grants are renewable depending upon annual maintenance of academic standards and the continued need for financial aid. All candidates must be recommended by the golf club where they have been employed for a minimum of two seasons. Applications are due by May 15, 2021, and may be obtained online at mcdonoughgolf.com. For more information, please email us at mcdonoughscholarship@gmail.com. Interviews are held in June and July, and grants are announced in August.

The President's Report



Fellow McDonough supporters,

Let me begin by thanking you for your support of our New Hampshire golf course employees. We could not have provided financial support to 92 students this past year without the generous donations of golfers from around our state. Like many other nonprofits, 2020 provided many challenges, and I am pleased to report

the McDonough Foundation was able to overcome these obstacles and continue our mission of providing undergraduate scholarships to worthy young people.


One of our challenges was having meetings with volunteers who serve on the McDonough board. Like others faced with the same challenge, we became adept at Zoom meetings and conference calls to conduct our business. We did finally manage to have one socially distanced board meeting, but I suspect it will be deep into 2021 before we meet in person again. In spite of these administrative challenges, McDonough is well positioned and poised to have another successful year in 2021. We also had to adapt our scholarship process to meet the demands of these unprecedented times. Normally, our directors would meet with our scholar applicants at various courses throughout the state to conduct brief interviews. Instead, we had applicants meet virtually with various members of the board via Skype or Zoom, for instance, in order to interview and evaluate our scholars. The board continues to report that our scholar recipients are a bright and motivated group.

After working through our various COVID-19-related challenges, which included canceling our annual Pro-Am golf tournament, we managed to award \$117,800 in scholarships to 92 young men and women employed at 27 New Hampshire golf courses. McDonough recipients are currently attending 46 colleges and universities. With these most recent awards, the Foundation has now awarded a total of \$2,873,310 in scholarship grants since inception of the program.

We were very pleased that despite the difficulties COVID-19 presented, the McDonough Foundation assets grew to over \$1 million for the first time. The rise in the equity markets was very helpful, but most importantly, we added four new endowed scholarships, bringing our total endowment to over \$800,000 for the first time. We are very grateful to the families that established these scholarships, especially the Erb family, who created a memorial scholarship for Bob Erb. Bob, who passed away this year, was a long-time board member and former president of the McDonough Foundation. We will miss him greatly.

As McDonough looks forward to 2021, the foundation aims to award \$127,000 in scholarships, which would be more than \$3 million total awarded since its 1955 founding. This milestone is well within reach and gives us a worthy goal as we look to rebound from the pandemic. And by the time you read this, we will have unveiled a new website that will be cleaner, more contemporary, and capable of accepting online donations. We also plan to return with our 38th Pro-Am tournament in the fall of 2021... *stay tuned for details!*

Finally, I have decided that 2021 will be my last year as president. Back in 2008, I was recruited for the board and have chaired the Pro-Am for 12 years. I have served as secretary, managing director, and vice president, before becoming president back in late-2018. In 2020, I took on the role of interim scholarship chair and enjoyed



it very much. I plan to remain on the McDonough board, remove the "interim" title, and continue as scholarship chair for the foreseeable future, as I very much enjoy seeing the academic growth and maturation of our scholars.

The McDonough presidency will transfer into the extremely capable hands of Bill Everett of Laconia Country Club. Bill is the current vice president and chair of our Permanent Fund Committee, which manages the assets of our endowed scholarships. He has been instrumental in the creation of several new permanently endowed scholarships and will have the support of nearly 20 volunteer directors from around the state. I have every confidence that McDonough will continue to maximize your donated dollars for the benefit of New Hampshire's golf course employees.

McDonough Scholarships

For academic year 2020-2021, the Foundation granted \$117,800 in scholarship grants to 92 applicants, who represented 27 golf clubs throughout the state of New Hampshire. Of this year's recipients, 22 entered as freshmen, 20 as sophomores, 30 as juniors, and 20 as seniors. Thirty-three of these scholars are attending seven New Hampshire colleges and universities; the other 59 are pursuing their degrees at 39 different colleges and universities around the country.

Endowed Scholarships

The McDonough Foundation has a range of permanently endowed scholarships. Each of these awards has been funded by contributions from families or organizations and is named after an individual who was or is deeply committed to golf and the education of New Hampshire youths.

The Bald Peak Colony Club Scholarship

Endowed by ten present and former members of the Colony Club and awarded annually to an employee of the club.

The 2020 recipient is Kathryn Duddy of Bald Peak Colony Club, who is attending Lancaster Bible College.

The Macomber-Bird Scholarship

Established in 2020, this scholarship was endowed by Grace and Jerry Bird in honor of Grace's parents, George and Ann Macomber, who were long-time members of the Bald Peak Colony Club. The scholarship is awarded annually to an employee of Bald Peak Colony Club who has demonstrated outstanding character and service to the club.

The 2020 recipient is Erik Madden of Bald Peak Colony Club, who is attending Wentworth Institute of Technology.

The Dr. George T. Bottomley Scholarship

Endowed by the Bottomley family and the Fuller Foundation in his memory and awarded annually to an employee of Abenaqui Country Club or a club in the New Hampshire seacoast area.

The 2020 recipient is Joe Early of Abenaqui Country Club, who is attending Nichols College.

The Jim Kinhan Directors' Excellence Award

Endowed by present and former directors of the McDonough Foundation in memory of Jim Kinhan and awarded on an annual basis to a scholar who has shown academic achievement together with outstanding citizenship and community involvement.

The 2020 recipient is Jake Rappaport of Cochecho Country Club, who is attending University of New Hampshire.

The Dr. Robert Elliott Memorial Scholarship

Endowed by the New Hampshire Golf Association in his memory and in recognition of his many years of service to the New Hampshire golfing community. The scholarship is awarded annually to the college senior scholar with the highest cumulative grade point average through their previous work.

The 2020 recipient is Megan Duddy of Bald Peak Colony Club, who is attending Cedarville University.

The Robert C. Erb, Sr. Scholarship

Endowed by his wife and son in recognition of his long-time support of the education of New Hampshire youths and their involvement in the game of golf. Awarded annually to a young man or woman who has demonstrated outstanding character and academic achievement.

The 2020 recipient is Christopher DeYoung of Apple Hill Golf Course, who is attending University of New England.

The Bob Erb Scholarship

Endowed by Bob's family and friends in recognition of his long-time service as a board member and past president of the McDonough Foundation. As a born and bred New Hampshire golfer and avid supporter of the McDonough Foundation, he took great pleasure in watching McDonough scholars succeed. This scholarship is awarded annually to a young man or woman employed at a New Hampshire golf course who has demonstrated the same love and respect of the game of golf that Bob embodied every time he stepped on the course.

The 2020 recipient is Dawson Ellis of Laconia Country Club, who is attending St. Anselm College.

The Alex Gissler Memorial Scholarship

Endowed by the members of Baker Hill Golf Club in his memory as an outstanding young man and loyal employee. The scholarship is awarded on an annual basis to a young man or woman employed at Baker Hill Golf Club.

The 2020 recipient is George Henrich of Baker Hill Golf Club, who is attending University of New Hampshire.

The Stan Lencki Scholarship

Endowed by the Manchester Country Club membership together with friends of Mr. Lencki in honor of his 50 years of service to the club. The scholarship is awarded annually to a young man or woman who has demonstrated a specific need for financial aid as determined by the Scholarship Committee.

The 2020 recipient is Mitchell Mahoney of Nashua Country Club, who is attending University of New Hampshire.

The Thomas L. DiFonzo Scholarship

Endowed by members of Laconia Country Club and awarded, on an annual basis, to an employee of Laconia Country Club who has shown financial need and a commitment to their ongoing education.

The 2020 recipient is Ryan Cashman of Laconia Country Club, who is attending Kent State University.

The Rick Mahoney Scholarship

Endowed by the McDonough Foundation in honor of Mr. Mahoney's 25-plus years of service as director of the Foundation and chairman of the Scholarship Committee. The scholarship is awarded annually to a young man or woman who is a resident of Nashua, NH, employed at a New Hampshire golf course.

The 2020 recipient is Kayla Bednarz of Nashua Country Club, who is attending Rivier University.

The Walter T. Philippy Scholarship

Endowed in his memory by the Philippy family. Walter was a 48-year veteran of Derryfield Country Club and an advocate of young peoples' involvement in the game of golf. The scholarship is awarded on an annual basis to a deserving candidate employed at Derryfield Country Club or a Manchester, NH, golf club.

The 2020 recipient is Declan Clougherty of Derryfield Country Club, who is attending Georgia Tech.

The David J. Pollini Scholarship

Endowed by the Kingswood Golf Club membership and friends of Mr. Pollini in his honor, upon his retirement, of his 39 years of service as head professional at Kingswood Golf Club. The scholarship is awarded annually to an employee of Kingswood Golf Club or Lakes Region golf course.

The 2020 recipient is Jacob Jensen of Kingswood Golf Course, who is attending Northeastern University.

The New Hampshire Senior Golf Association Scholarship

Endowed by the NHSGA and awarded annually to an employee of any New Hampshire golf course who has demonstrated academic excellence and a commitment to the game of golf.

The 2020 recipient is Hunter Drew of Bretwood Golf Course, who is attending University of New England.

The Jim Sheerin Scholarship

Endowed by the Abenaqui Country Club membership and friends of Jim in honor of his many years of service as head golf professional and director of golf. A long-time supporter and board member of the McDonough Foundation and committed to introducing young people to the game of golf as illustrated by his caddie program and youth golf camps. The scholarship is awarded on an annual basis to a deserving candidate employed at Abenaqui Country Club or another Seacoastarea golf course.

The 2020 recipient is Lars Hamilton of Abenaqui Country Club, who is attending University of New Hampshire.

The Eastman Golf Links Scholarship

Endowed by the members of the Eastman Golf Links, the scholarship will be awarded annually to a young man or woman employed by the club who has clear financial need. In addition, they will have demonstrated high academic achievement and a record of service to their school or community.

The 2020 recipient is Naomi Nelson of Eastman Golf Links, who is attending Franciscan University of Steubenville.

The Wilson Kurtz Family Scholarship

This scholarship was endowed by David Wilson, a long-time McDonough board member, in memory of his late wife, Marcia Wilson. The scholarship will be awarded annually to a young man or woman who works at Cochecho Country Club. The recipient will be a scholar who is entering their sophomore, junior, or senior year in college. The award will be based primarily on a combination of academic achievement and financial need, with interest in golf as a secondary consideration.

Additional Named Scholarships

In addition to the Endowed Scholarships, four additional named scholarships are funded on an annual basis.

The Pauline Elliott Scholarship

Funded on an annual basis by the New Hampshire Golf Association in honor and appreciation of the late Pauline's efforts on behalf of the NHGA.

The 2020 recipient is Cole Schmitz of Abenaqui Country Club, who is attending Washington University.

The Phil Friel Scholarship

Funded on an annual basis by the McDonough Foundation in honor of one of the great gentlemen of New Hampshire golf. The scholarship is awarded annually to an outstanding McDonough scholar who intends to pursue a career in the golf industry.

The 2020 recipient is Nicholas Grimbilas of Portsmouth Country Club, who is attending Endicott College.

The New England Senior Golfers' Association Scholarship

Funded on an annual basis by the NESGA and awarded on an annual basis to a McDonough senior scholar who has demonstrated, over their previous three years, ongoing academic excellence, continuing financial need, and extracurricular participation.

The 2020 recipient is Griffin Chenard of Golf Club of New England, who is attending Rensselaer Polytechnic Institute.

The Pope Scholarship Award

Funded on an annual basis by the membership of Concord Country Club in memory of the former University of New Hampshire golf coach and Concord Country Club member, Ken Pope.

The 2020 recipient is Jack Olson of Concord Country Club, who is attending Tulane University.

1. What is the McDonough Scholarship Foundation?

The McDonough Foundation is a volunteer organization whose sole mission is to solicit monies on an annual basis for the purpose of awarding college scholarships to those employed at New Hampshire golf courses, who are attending colleges and universities of their choice. The Foundation is a not-forprofit organization. Its Employer Identification Number is 02-6012491, and copies of its 501(c)3 and W-9 forms are available upon request.

2. Who is qualified to apply for a McDonough

Scholarship grant? Any student employee of a New Hampshire golf course or club may apply. This includes pro shop, grounds, wait, kitchen, and office staff. All candidates must be recommended by the golf club where they are in at least their second year of employment and must demonstrate promise of academic success, as well as require financial assistance. Once awarded, a McDonough scholarship may be renewed each year for a total of four years. Annual grants are renewable, upon application, depending upon annual maintenance of academic standards and the continued need for financial aid.

3. How are the scholarship recipients chosen? New applicants and previous recipients are interviewed by a member of the McDonough Board of Directors on an annual basis. Candidates must maintain a minimum 2.5 GPA and continue to show financial need. Their qualifications are reviewed, and an award is made based on meeting the criteria set forth by the Board of Directors.

4. If a scholarship recipient does not return to his or her employing club, are they still qualified to apply for a scholarship grant the following academic year? Yes. Often scholarship recipients will attend summer school or take an internship in their chosen field. They are still qualified to apply for their upcoming academic year.

5. What is the average of the annual awards total? Over the past 15 years, total annual awards have averaged \$109,000; \$2,873,310 has been awarded since the inception of the program.

6. What are the Foundation's primary sources of revenue? Annual revenue averages \$130,000, of which approximately \$90,000 is generated through New Hampshire golf club contributions. Additional revenue is from contributions made by individuals, the New Hampshire Golf Association, the New Hampshire Senior and Profile Senior Golfers' Associations, the New Hampshire Chapter of the New England Professional Golf Association, and the New England Senior Golfers' Association, together with income derived from the McDonough Annual Benefit Golf Tournament and investment income from the McDonough Permanent Fund.

For the year 2020, total annual revenue of \$132,500 broke out as follows:

7. What percent of annual donations actually goes toward scholarship grants? 89% of monies raised on an annual basis go toward the scholarship grants. This is possible as the McDonough Foundation is a volunteer organization with only one paid administrative staff member. From time to time, expenses incurred involve the McDonough Annual Dinner, the McDonough Annual Benefit Golf Tournament, and some promotional materials. The Foundation is extremely fortunate to have legal and accounting services donated, as well as the majority of printed promotional materials.

8. Does the amount donated by a given club have any bearing on the amount awarded to an employee(s)? No. In 2020, 18 clubs and associations donated to the Foundation, with recipients representing 27 clubs.

9. What is the McDonough Permanent Fund? The fund, currently valued at \$827,000, is an endowment fund created in April 2000 to help ensure the continuation of the scholarship program for years to come. To date, 17 named scholarships (see pages 3 and 4) have been endowed with contributions by families, individuals, and organizations in honor of someone who was or is deeply committed to golf and the education of New Hampshire youth. The annual interest earned from these named scholarships, together with unrestricted gifts, is applied to annual scholarship awards. Cambridge Trust Wealth Management is the custodian and investment advisor for the Permanent Fund.

10. What is the McDonough Heritage Society? This is an adjunct to the Permanent Fund, which provides an opportunity for individuals to make bequests to the Foundation as part of their estate planning. Bequests and other planned gifts are important sources of revenue to the Foundation and when received, become part of the Permanent Fund or designated as specified by the grantor.

11. How can I help and/or get involved? There are many ways! Make a financial contribution, volunteer to become the McDonough ambassador at your club, serve as a McDonough liaison within your local business community, or inform friends of the McDonough "mission." Consider becoming a member of the McDonough Board.

Donation Programs

Many individuals, corporations, foundations, and golf organizations support the McDonough Foundation. Some of the donor opportunities follow:

General Contributions

The Foundation welcomes all general contributions from individuals, corporations, foundations, or golf organizations. All contributions are acknowledged and are fully tax deductible.

Endowed Scholarships

The McDonough Permanent Fund, an endowment fund, provides an avenue for families or organizations to endow a named scholarship in honor or memory of an individual who was or is deeply committed to golf and the education of New Hampshire youths.

Non-endowed Scholarships

Non-endowed scholarships provide the opportunity for individuals, associations, and corporations to fund a scholarship on an annual basis in the name of an individual or association.

McDonough Heritage Society

The McDonough Heritage Society is an adjunct to the Permanent Fund providing an opportunity for individuals to make bequests to the Foundation as part of their estate planning. Bequests and other planned gifts are important revenue to the Foundation and when received can become part of the Permanent Fund or designated as specified by the grantor. The Foundation extends its appreciation to those individuals who have considered the Foundation by way of bequests.

McDonough Permanent Fund "Funding for the 21st Century"

The McDonough Permanent Fund, an endowment fund, was created in April 2000, with the express intent of providing an avenue whereby a donor or donors could establish an endowed scholarship in the honor of an individual or in memory of a loved one. To date, 17 named scholarships have been endowed (see pages 3 and 4) in the amount of \$827,000. In addition, there are currently four additional named scholarships (see page 4) which are funded on an annual basis by various associations in honor of or in memory of an individual or in the name of the association.
