The President's Report



McDonough Supporters and Scholars,

Thank you for your financial support of the McDonough Foundation in 2021. We could not have provided scholarships to 87 students this past year without the generous donations from golfers around New Hampshire. I am pleased to report that the McDonough Foundation was able to again overcome the obstacles associated

with Covid-19 to continue our mission of providing undergraduate scholarships to these worthy young people.

In February, we rolled out our new and improved website. Director Keith Boyle (Laconia CC) worked with web designer Philippa Middleton and Lisa Kress, McDonough's Director of Communications, to handle the transition and add new content. McDonough can now accept online donations through PayPal and we are working on other models for processing donations. Please check out the new website at www.mcdonoughgolf.com.

We continued to have a varied scholarship process in 2021, with a mix of virtual and in-person interviews to evaluate our scholars. Normally, our directors would meet with our scholar applicants at various courses throughout the state in order to conduct brief interviews. Additionally, we had applicants meet electronically with various members of the board via Skype, Zoom, etc., to complete the scholarship process. The board continues to report that our scholar recipients are a bright and motivated group.

After working through our various Covid-19-related challenges, we returned to hosting our 37th Annual Pro-Am Golf Tournament, at the Lake Winnipesaukee Golf Club in August. We had a very successful event and raised nearly \$15,000 toward scholarships. We also had a milestone year, awarding \$131,800 to 87 scholars from around New Hampshire. McDonough recipients are currently attending 38 colleges and universities. With these most recent awards, the Foundation has crossed the \$3 million threshold in scholarship grants since 1955.

Finally, this will be my last report to you as President. In December, I passed the baton to Bill Everett, of Laconia CC, who has chaired our Endowment Committee and been vice president of McDonough for the last three years. Bill has been instrumental in growing our endowment over the last several years, and I have every confidence that McDonough will continue to maximize your donated dollars for the benefit of New Hampshire's golf course employees. I'll continue to volunteer as the Scholarship Chair, as I enjoy meeting our great McDonough scholars from around New Hampshire.

Requirements for McDonough Scholars

Any student employee of a New Hampshire golf course or club is eligible to apply for a scholarship. Candidates should demonstrate promise of academic success, as well as require financial assistance. Grants are renewable for up to four years in total, depending upon annual maintenance of academic standards, the continued need for financial aid, as well as the duration of the scholar's intended program. All candidates must be recommended by the golf club where they have been employed for a minimum of two seasons. For more information about the program, or to submit an application, visit our website at mcdonoughgolf.com. Applications and all required documentation must be received no later than May 15.

Interviews with each eligible scholar are held in June and July. Grants are announced in August.

The McDonough Foundation is an equal opportunity scholarship program and does not discriminate on the basis of sex, race, religion, or ethnic origin.

McDonough Scholarships

For academic year 2021-2022, the Foundation awarded \$131,800 in scholarship grants to 87 applicants, representing 27 golf clubs throughout the state of New Hampshire. Of this year's recipients, 27 entered as freshmen, 22 as sophomores, 12 as juniors, and 26 as seniors. Thirty-three of these scholars are attending six colleges and universities located in New Hampshire; the 54 remaining are pursuing their degrees at 32 other colleges and universities around the country.

Endowed Scholarships

The McDonough Foundation has a range of permanently endowed scholarships. Each of these awards has been funded by contributions from families or organizations and is named after an individual who was or is deeply committed to golf and the education of New Hampshire youths.

The Bald Peak Colony Club Scholarship

Endowed by ten present and former members of the Bald Peak Colony Club, this scholarship is awarded annually to an employee of the club.

The 2021 recipient is Joseph D'Ambruoso of Bald Peak Colony Club, who is attending the University of New Hampshire.

The Dr. George T. Bottomley Scholarship

Endowed by the Bottomley family and the Fuller Foundation in his memory and awarded annually to an employee of Abenaqui Country Club or a club in the New Hampshire seacoast area.

The 2021 recipient is Robert DeVito of Abenaqui Country Club, who is attending the University of New Hampshire.

The Thomas L. DiFonzo Scholarship

Endowed by members of Laconia Country Club and awarded, on an annual basis, to an employee of Laconia Country Club who has shown financial need and a commitment to their ongoing education.

The 2021 recipient is Sam Stafford of Laconia Country Club, who is attending New Hampshire Technical Institute.

The Eastman Golf Links Scholarship

Endowed by the members of Eastman Golf Links, the scholarship is awarded annually to an employee of the club who has clear financial need. In addition, they will have demonstrated high academic achievement and a record of service to their school or community.

The 2021 recipient is Logan French of Eastman Golf Links, who is attending the University of New Hampshire.

The Dr. Robert Elliott Memorial Scholarship

Endowed by the New Hampshire Golf Association in his memory and in recognition of his many years of service to the New Hampshire golfing community. The scholarship is awarded annually to the college senior scholar with the highest cumulative grade point average through their previous work.

The 2021 recipient is Ellen McKenna of Nashua Country Club, who is attending St. Michael's College.



The Bob Erb Scholarship

Endowed by Bob's family and friends in recognition of his long-time service as a board member and past president of the McDonough Foundation. As a born and bred New Hampshire golfer and avid supporter of the McDonough Foundation, he took great pleasure in watching McDonough scholars succeed. This scholarship is awarded annually to an employee at a New Hampshire golf course who has demonstrated the same love and



respect of the game of golf that Bob embodied every time he stepped on the course.

The 2021 recipient is Christopher De Young of Apple Hill Golf Club, who is attending the University of New England.

The Robert C. Erb, Sr. Scholarship

Endowed by his wife and son in recognition of his long-time support of the education of New Hampshire youths and their involvement in the game of golf. Awarded annually to a young man or woman who has demonstrated outstanding character and academic achievement.

The 2021 recipient is Hannah Drew of Bretwood Golf Course, who is attending the University of Hartford.

The Alex Gissler Memorial Scholarship

Endowed by the members of Baker Hill Golf Club in his memory as an outstanding young man and loyal employee. The scholarship is awarded on an annual basis to an employee of Baker Hill Golf Club. No recipient was selected for 2021.

The Arnold and Carol Haynes Family Scholarship

Established and endowed in memory of Arnold and Carol Haynes by their three children, the scholarship is awarded annually to an employee of Bald Peak Colony Club who exhibits high character and meets the eligibility requirements of the McDonough Scholarship Foundation. The scholarship was established in 2021 in recognition of Arnold and Carol Haynes' love of the Bald Peak Colony Club. If no scholarship is awarded in any given year, the annual earnings will be added to the principal balance of the fund.

The 2021 recipient is Erik Madden of Bald Peak Colony Club, who is attending Wentworth Institute of Technology.

The 2021 recipient is Murray Mahoney of Nashua Country Club, who is attending the University of New Hampshire.


The Stan Lencki Scholarship

The New Hampshire Senior Golf Association Scholarship

Endowed by the NHSGA and awarded annually to an employee of any New Hampshire golf course who has demonstrated academic excellence and a commitment to the game of golf.

The 2021 recipient is Matthew Marino-Babcock of Abenaqui Country Club, who is attending the University of New Hampshire.



The Walter T. Philippy Scholarship

Endowed in his memory by the Philippy family. Walter was a 48-year veteran of Derryfield Country Club and an advocate of young peoples' involvement in the game of golf. The scholarship is awarded on an annual basis to a deserving candidate employed at Derryfield Country Club or a Manchester, NH, golf club.

The 2021 recipient is Abigail Conrad

of Derryfield Country Club, who is attending the University of Connecticut.

The David J. Pollini Scholarship

Endowed by the Kingswood Golf Club membership and friends of Mr. Pollini upon his retirement, honoring his 39 years of service as head professional at Kingswood Golf Club. The scholarship is awarded annually to an employee of Kingswood Golf Club or Lakes Region golf course.

The 2021 recipient is Jacob Jensen of Kingswood Golf Course, who is attending Northeastern University.

The Jim Sheerin Scholarship

Endowed by the Abenaqui Country Club membership and friends of Jim in honor of his many years of service as head golf professional and director of golf. Jim, a long-time supporter and board member of the McDonough Foundation, has been committed to introducing young people to the game of golf, as illustrated by his caddie program and youth golf camps. The scholarship is awarded on an annual basis to a deserving candidate employed at Abenaqui Country Club or another Seacoast-area golf course.

The 2021 recipient is Tristan Hamilton of Abenaqui Country Club, who is attending St. Lawrence University.

The Rich Thibeault Scholarship

Concord Country Club's members and Rich Thibeault's friends generously contributed toward funding the Rich Thibeault Scholarship Fund upon his retirement as the club's PGA Professional in 2021. The fund pays tribute to Rich's many years of service to the members and guests of Concord Country Club, as well as recognizing his loyal support of the McDonough Scholarship Foundation. Rich designated his named scholarship be awarded to a Concord Country Club scholar who has demonstrated specific need for financial aid, as determined by the Scholarship Committee. If no such Concord Country Club candidate exists, the award will be given to another candidate who best meets the criteria for the academic year. No recipient was selected for 2021, as the fund was newly established late in the year.

The New England Senior Golfers' Association Scholarship

Funded on an annual basis by the NESGA and awarded on an annual basis to a McDonough senior scholar who has demonstrated, over their previous three years, ongoing academic excellence, continuing financial need, and extracurricular participation.







Non-endowed scholarships provide the opportunity for individuals, associations, and corporations to fund a scholarship on an annual basis in the name of an individual or association.

Memorial Donations

Families often select the Foundation to receive donations when a loved one dies. The Foundation acknowledges such contributions, summarizes the gifts, and provides a list of contributors for the family.

Wills and Estates/Planned Giving

The McDonough Heritage Society is an adjunct to the Permanent Fund and provides individuals the opportunity to give back to the game of golf through their estate by naming the McDonough Foundation as a beneficiary in their will. Bequests and other planned gifts are important revenue to the Foundation and when received can become part of the Permanent Fund, or designated as specified by the grantor. The Foundation extends its appreciation to those individuals who have considered the Foundation by way of bequest

Frequently Asked Questions

What is the McDonough Scholarship Foundation?

The McDonough Foundation is a volunteer organization whose sole mission is to solicit monies on an annual basis for the purpose of awarding college scholarships to New Hampshire golf course employees, who are attending colleges and universities of their choice at the undergraduate level. The Foundation is a not-for-profit organization. Its Employer Identification Number is 02-6012491, and copies of its 501(c)3 and W-9 forms are available upon request.

Who is qualified to apply for a McDonough

Scholarship grant? Any student employee of a New Hampshire golf course or club may apply. This includes pro shop, grounds, wait, kitchen, and office staff. All candidates must be recommended by the golf club where they are in at least their second year of employment, must demonstrate the promise of academic success, as well as require financial assistance. Once awarded, a McDonough scholarship may be renewed for up to four years, depending upon annual maintenance of academic standards, the continued need for financial aid, and the duration of the scholar's intended degree or program. All scholarship candidates must submit an application annually, and be full-time students.

How are scholarship recipients chosen? New applicants and previous recipients are interviewed by a member of the McDonough Board of Directors on an annual basis. Candidates must maintain a minimum 2.5 GPA and continue to show financial need. Their qualifications are reviewed, and an award is made based on meeting the criteria set forth by the Board of Directors.

Does the amount donated by a given club have any bearing on the amount awarded to an employee(s)?

No. In 2021, 22 clubs and associations donated to the Foundation.

No. In 2021, 22 clubs and associations donated to the Foundation, with recipients representing $33\ \text{clubs}$.

If a scholarship recipient does not return to their employing club, are they still qualified to apply for a scholarship grant the following academic year?

Yes. Often scholarship recipients will attend summer school or take an internship in their chosen field. They are still qualified to apply for their upcoming academic year.

What are the average total annual awards? Over the past five years, total annual awards have averaged \$122,584. A total of \$3,005,110 has been awarded since the inception of the program.

What percent of annual donations actually goes toward scholarship grants? In 2021, 68% of the monies raised went toward scholarship grants. This percentage is lower than prior years (which averaged 89%) due to the uncertainties created by Covid-19 and the high percentage of funds received later in the year after the scholarships were awarded and paid out. Our historically high-payout percentage is because the McDonough Foundation is a volunteer organization with only one part-time paid administrative staff member. From time to time, expenses incurred involve the McDonough Annual Benefit Golf Tournament, and some promotional materials. The Foundation is extremely fortunate to have donated legal and accounting services and the majority of printed promotional materials.

What are the Foundation's primary sources of

revenue? In 2021, the Foundation had total revenue of \$194,863, of which \$91,176 was generated through New Hampshire golf club contributions. An additional \$62,887 was received from individuals, the New Hampshire Golf Association, the Profile Senior Golfers' Association, and the New England Senior Golfers' Association, together with profits from the McDonough Annual Benefit Golf Tournament. Investment income from the McDonough Permanent Fund was \$40,800 for the year.

What is the McDonough Permanent Fund?

The McDonough Permanent Fund, currently valued at \$1,016,125, is an endowment fund created in April 2000 to help ensure the continuation of the scholarship program for years to come. To date, 19 named scholarships have been endowed with contributions by families, individuals, and organizations in honor of an individual who was or is deeply committed to golf, and the education of New Hampshire youth. The annual earnings from these named scholarships, together with unrestricted gifts, is applied to annual scholarship awards. Cambridge Trust Wealth Management is the custodian and investment advisor for the Permanent Fund.

What is the McDonough Heritage Society?

The McDonough Heritage Society is an adjunct to the Permanent Fund, which provides an opportunity for individuals to make bequests to the Foundation as part of their estate planning. Bequests and other planned gifts are important sources of revenue to the Foundation and when received, become part of the Permanent Fund or designated as specified by the grantor.

How can I help and/or get involved? There are many ways. For example, making a financial contribution, volunteering to become the McDonough ambassador at your club, serving as a McDonough liaison within your local business community, or informing friends of the McDonough "mission." Consider becoming a member of the McDonough Board.
